- **State Agency Member** – Any active duty recruiter, human resources specialist, or applicant investigator who recruits public safety personnel for a recognized **STATE** law enforcement, corrections, or other related government agency.
- **Federal Agency Member** – Any active duty recruiter, human resources specialist, or applicant investigator who recruits public safety personnel for a recognized **FEDERAL** law enforcement, corrections, or other government agency.
- **Tribal Law Enforcement Agency**- Any active duty recruiter, human resources specialist, or applicant investigator who recruits public safety personnel for **TRIBAL** law enforcement, corrections, security or other government agency.
- **Campus Agency Member** – Any active duty recruiter, human resources specialist, or applicant investigator who recruits public safety personnel for a recognized **SCHOOL, UNIVERSITY OR COLLEGE** law enforcement OR public safety agency.
- **Private Security Industry Member** – Any active duty recruiter, human resources specialist, applicant investigator or trainer engaged in managing, supporting, recruiting, or providing training the recruitment of candidates for law enforcement, military or security positions on behalf of a major **Private Security** firm.
- **Military Service Member**– Any military service recruiter, human resources specialist, or applicant investigator who recruits public safety personnel for a **US Military Service or affiliated branch agency**.
